Pond Harvesting - For the fourth consecutive year, we coordinated the harvesting of algae and water chestnut from Carding Mill Pond. Due to diminished harvester availability and mechanical problems, only a portion of the pond was harvested. Expenses of \$3,842 were fully reimbursed by the Town of Sudbury. This stop-gap measure will continue until true remediation is underway.

Pond Remediation - In a few years' time, when Marlboro completes the upgrade of the MEWTP to meet the permit requirements, the ponds will require dredging to remove the rooted weeds and accumulate nutrients in the layers of dead biomass. The first step in this long-term project is to raise funds for the permitting process required for dredging. A fundraiser was held for this purpose and the revenues and expenses are reported under Special Events.
