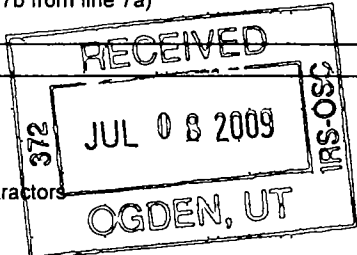

Description

Pond Harvesting - For the fifth consecutive year, we coordinated the harvesting of algae and water chestnut from Carding Mill Pond. This stop-gap measure will continue until true remediation is underway. Expenses of \$3,842 from 2007 were fully reimbursed by the Town of Sudbury in 2008. Expenses of \$10,347 for 2008 included the unusually large amount of \$7,141 for harvester maintenance. Reimbursement in 2009 for most of these expenses is expected from the Town of Sudbury and from other towns who use the harvester.

Statement 3 - Form 990-EZ, Part III, Line 30 - Statement of Program Service Accomplishments

Description

Pond Remediation - In a few years' time, when Marlboro completes the upgrade of the MEWTP to meet the permit requirements, the ponds will require dredging to remove the rooted weeds and accumulate nutrients in the layers of dead biomass. The first step in this long-term project is to raise funds for the permitting process required for dredging. Fundraisers were held in the fall of 2005, 2006 and 2007. The next fundraiser is planned for the spring of 2009.
