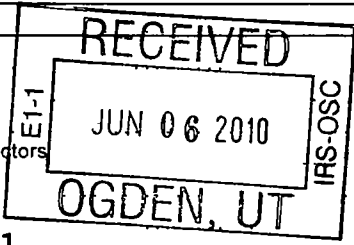

Statement 2 - Form 990-EZ, Part III, Line 28 - Statement of Program Service Accomplishments

Description

Citizen Action - Action in the form of letter writing and meetings with officials was taken to alert the EPA to the fact that the City of Marlboro was seriously slipping in its schedule to upgrade their water treatment plant to meet permit requirements. The result is that the EPA had to make a new schedule, but it has issued orders for Marlboro to comply with it at the risk of incurring penalties.

Statement 3 - Form 990-EZ, Part III, Line 29 - Statement of Program Service Accomplishments

Description

Pond Harvesting - For the sixth consecutive year, algae and water chestnut were harvested from Carding Mill Pond. Although this is only a stop-gap measure and will continue until true remediation is underway, six years of harvesting have effected a decided improvement in pond health, with considerably less growth to harvest this year compared to last year. Expenses totalled \$2,860 (fully reimbursed by the Town of Sudbury in 2010). Expenses of \$10,347 for harvesting in 2008, which included the unusually large amount of \$7,141 for harvester maintenance, were partially reimbursed in 2009 in the amount of \$8,000.

Statement 4 - Form 990-EZ, Part III, Line 30 - Statement of Program Service Accomplishments

Description

Pond Remediation - When the upgrade of the water treatment plant is complete, the ponds will require dredging to remove the rooted weeds and accumulate nutrients in the layers of dead biomass. In continuing efforts to raise funds for the permitting process required for dredging, a fourth fundraiser was held in 2009 (reported under Special Events).
