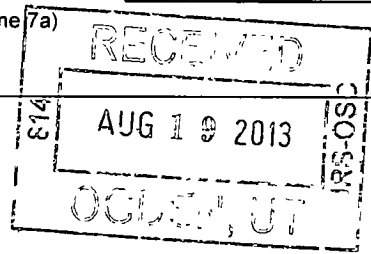



Although this is only a stop-gap measure and will continue until true remediation is underway, nine years of harvesting have effected a decided improvement in pond health, with considerably less growth to harvest from one year to the next.
