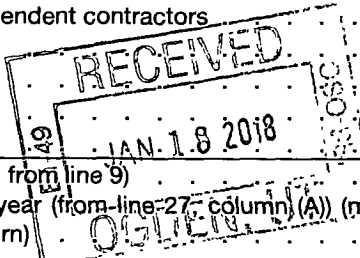

Part V Line 34. The following changes were approved for our ByLaws at the Annual Board of Directors Meeting, June 12, 2017:

1) Art. II Section 1: The number of directors constituting the entire Board was changed from 5 to a minimum of five (5) and a maximum of (9).

2) Art. II Section 2: Changed from: The directors shall be elected for a term of one year at the annual Board of Directors meeting by a majority of directors then in office and shall continue in office until a successor is elected, or until death, resignation, or removal.

Changed to: The directors shall be elected for a term of one year, the term to begin January 1 and to end December 31 for the calendar year. The directors shall vote for the coming year's directors either (1) at the annual meeting of the Board of Directors, (2) by written vote at the end of the year, or (3) in the event of a need to fill an unexpected vacancy, by written vote as determined by the President of the Board of Directors.

3) Art. II Section 2 (b) Procedure for nomination: Changed from voting only at the annual meeting, changed to include by written ballot

4) Art. II Section 5: Vacancies and newly created directorships: Changed from being filled either at any meeting of the Board of Directors

Changed to include nomination by a written vote. Added: directors elected shall serve to the end of the calendar year.

5) Art. III Section 4: Discussing vacancies in the officers: to be filled by the Board of Directors and serve until the next annual meeting.

Changed to: filled by vote either at any meeting of the Board of Directors or by written vote and serve until the end of the calendar year.

6) Art. II Section 2: (ix) prohibited substantial contributors from being a member of the Board of Directors.

Changed to: (ix) a substantial contributor may be a member of the Board of Directors and may be an officer.

Included: (x) conflicts of interest. This new section defined the terms, "interest," and "concern." This new section laid out five points to deal with person on the board who would have a conflict of interest. These points included the person with the conflict disclosing the conflict, not being allowed to vote or be counted in the quorum on a matter concerning the conflict of interest. If there is any payment to be made to a person with a conflict of interest, it is not to exceed the fair market value. In addition, the minutes of meetings at which such votes are taken shall record such disclosure, abstention, and rationale for approval. This would include such a written statement written statement in any voting packet or agenda.
