The Museum is a member of the University of the State of New York under the auspices of the Regents of the State of New York and is accredited by the American Association of Museums. AMNH constitutes a complex, multifaceted organization with broad international scope and impact. For over a century, AMNH has been a leader in research in the natural sciences and anthropology, as well as in museum education and exhibition. The AMNH mission, which reflects a close integration of science and education, is "to discover, interpret, and disseminate - through scientific research and education - knowledge about human cultures, the natural world, and the universe." In fiscal 2007, the Board of Regents of the State of New York amended the AMNH charter to establish a graduate school, making it the first and only museum in the U.S. to be authorized to grant a Ph.D. degree. The Richard Gilder Graduate School (the "Graduate School") was thus established and in fiscal 2007 AMNH received pledges totaling \$54 million designated for endowment by the Board of Trustees to support the Graduate School. The Graduate School will commence admission of students in the Fall, 2008. The AMNH campus sits in the middle of the approximately 18-acre Theodore Roosevelt Park of the City of New York on Manhattan's Upper West Side, with a complex of 25 interconnected buildings totaling 1.6 million square feet and housing 46 permanent halls and temporary exhibition galleries, a planetarium, research and collections facilities, classrooms, laboratories, and a library in the natural sciences, with parking and food service amenities for the convenience of visitors.</p> <p>MUSEUM EXHIBITIONS and VENUES AMNH exhibitions are open to the public 363 days a year. The AMNH permanent exhibition halls provide a field guide to life on Earth, the cultures of humanity, and the universe and are supplemented throughout the year with a robust program of award-winning temporary exhibitions, almost all created, designed and built by AMNH staff. Millions of people from around the nation and the world visit AMNH annually, and AMNH was voted the most popular family attraction in New York City and the third most popular family destination in the United States in the Zagat Survey U.S. Family Travel Guide. Over the past thirteen years, AMNH has built or renovated more than 12 of its 46 permanent exhibition halls, including the iconic David H. Koch Dinosaur Wing, the Milstein Hall of Ocean Life, the Hall of Biodiversity, all with updatable elements to present the newest research. In 2007, the Museum opened the Anne and Bernard Spitzer Hall of Human Origins that presents the remarkable history of human evolution from our earliest ancestors millions of years ago to modern Homo sapiens. The Spitzer Hall combines up-to-date discoveries in the fossil record with genomic science to explore the history and nature of humans - where we came from, who we are, and what might lie ahead for the future of our species. In addition to the permanent halls, the Museum produces special temporary exhibitions and science bulletin displays for exhibition on-site at AMNH and distributes them for display at museums, science centers, and other venues, now in 20 countries on six continents. Ancient Fossils, New Discoveries - explores how the latest technology and discoveries made during the last decade are shedding new light on dinosaur traits and behavior.-Totems to Turquoise: Native North American Jewelry Arts of the Northwest and Southwest - explores the longstanding cultural traditions surrounding Native American jewelry arts, including the techniques, materials, and styles that have evolved over the past 100 years.-Petra: Lost City of Stone - examines the ancient city of Petra, and its creators, the Nabataeans.-Vietnam: Journeys of Body, Mind & Spirit - presents Vietnamese culture in the early 21st century while taking visitors on a journey through this culturally diverse country of more than 50 ethnic groups.-Einstein - profiles this extraordinary scientific genius through a series of comprehensive exhibits that include letters and

The staff is led by 43 curators who along with Museum graduate students, postdoctoral fellows and research associates publish over 500 scientific articles per year in major peer-reviewed journals. The Museum also presents significant international scientific conferences on important and topical issues, including Stellar Collisions, Mergers, and Their Consequences, Sequencing the Human Genome, New Frontiers in Science and Technology, New Directions in Cluster Supercomputing, and Assembling the Tree of Life. Science, Relevance, and Challenges. AMNH scientists engage in joint research and cooperative agreements with many universities, including Columbia, Harvard, Florida, Stanford, NYU, California, City University of New York, Ohio State, Colorado, Hawaii, San Diego State, and the University of Barcelona, and with several scientific institutions, including The Smithsonian Institution, the Field Museum, The Royal Ontario Museum, Western Australian Museum, and The Australian Museum. AMNH also works in partnership with research institutes including NASA's Jet Propulsion Laboratory. The work of AMNH scientists has been partially funded by 14 different federal agencies including the National Science Foundation, the National Institutes of Health, the National Endowment for the Humanities, and the National Aeronautics and Space Administration. In Fall 2008, the Richard Gilder Graduate School will admit its first class of students in its Ph.D. program in comparative biology and has applied for accreditation of the program from the Regents of the State of New York. In addition, the Museum's long-standing doctoral training and post-doctoral professional development program will be placed under the auspices of the new Graduate School. That program is currently in collaboration with the following universities: Cornell, Columbia, New York University, and the City University of New York, serving approximately 40 postdoctoral fellows and 60 doctoral candidates. Described below are the AMNH scientific institutes and centers - the Sackler Institute of Comparative Genomics, the Rose Center for Earth and Space, and the Center for Biodiversity and Conservation - as well as the Museum's collections and research library.</p> <p>THE SACKLER INSTITUTE FOR COMPARATIVE GENOMICS The Institute pursues seminal research in the study of gene variation with approximately seventy individuals, including Museum curators, doctoral students from collaborating universities, postdoctoral students, and visiting scientists. Current research areas include: Evolution - advancing understanding of the evolution of species and the "tree of life", Environment - furthering the biodiversity conservation applications of genomics research, Human Health - determining how non-human genomics research can be applied to understanding human health and disease, and Innovation - developing technology, tools, software, and methods to solve complex biological problems. Among the Institute's facilities are three state-of-the-art molecular laboratories within the AMNH complex, a parallel-computing facility powered by more than 500 individual processors, and a frozen tissue collection-the Ambrose Monell Collection for Molecular and Microbial Research. The powerful, highly sophisticated parallel-computing facility, along with innovative algorithms developed by Museum researchers, allows scientists to construct phylogenies from massive amounts of data that range from fossil traits to DNA sequences. Further supporting this research, the Museum's new frozen tissue facility will be the largest and most comprehensive of its kind, housing a collection of up to one million specimens of DNA from a wide range of species.</p> <p>ROSE CENTER FOR EARTH AND SPACE HAYDEN PLANETARIUM The opening of the Rose Center for Earth and Space in February 2000 represented one of the Museum's most exciting and ambitious achievements. The monumental 120-foot-high, 333,500-square-foot</p>

It is a center for scientific research, an educational resource, a technological innovation, and an architectural icon that has become a destination for visitors from around the world. The Rose Center encompasses a completely rebuilt Hayden Planetarium and spectacular exhibition halls - the Cullman Hall of the Universe and the Gottesman Hall of Planet Earth - that compare the vast range of sizes in the cosmos, visualize the more than 13-billion-year history of the universe, explore the fascinating nature of galaxies, stars, and planets, and examine the dynamic features of our own planet Earth. Dominating the Rose Center is the magnificent Hayden Sphere, which features one of the world's largest virtual reality simulators. Weighing four million pounds and measuring 87 feet in diameter, the Hayden Sphere houses the Space Theater in its upper half and the Big Bang Theater in its lower hemisphere. With the custom-made Zeiss Projector and a state-of-the-art digital Projection System, the 429-seat Space Theater displays an astonishingly realistic view of planets, star clusters, nebulae, and galaxies in an exhilarating journey from Earth to the edge of the observable universe. To create this virtual universe, a team of Museum scientists and visualization experts, along with colleagues from such organizations as NASA, worked in a collaboration of science, artistry, and advanced computing to "stitch together" images of our universe, based on astronomical observations and computer models. The Museum creates space shows for exhibit in the Hayden and distributes them to over 30 planetaria worldwide. The Rose Center for Earth and Space is also home to the AMNH Department of Astrophysics. The department conducts research in observational, theoretical, and computational astrophysics, and provides curatorial support for the exhibitions and programs of the Rose Center. The researchers partner with NASA and use land- and space-based telescopes to further their work.</p> <p>CENTER FOR BIODIVERSITY AND CONSERVATION The Center for Biodiversity and Conservation (CBC) is committed to mitigating threats to biodiversity worldwide through research, outreach, education, and policy development. It expands scientific research on diverse species in critical ecosystems, uses rigorous scientific results to enhance conservation strategies and inform public policy, it builds professional and institutional capacity in countries where it works, and it contributes to efforts that aim to heighten public understanding and stewardship of biodiversity. The CBC forges key partnerships to conduct conservation-related field projects around the world, train scientists, organize scientific symposia, present public programs, and produce publications geared toward scientists, policy makers, and the lay public. One notable project is underway in the Bahamas where CBC researchers and colleagues are analyzing the physical, biological, economic, and cultural processes affecting reef ecosystems, with the objective of integrating these aspects into recommendations for conservation strategies. In Bolivia, Argentina, Chile, and Peru, the CBC is working on flamingo and wetland research and conservation. In Madagascar, the CBC's work, in partnership with the Wildlife Conservation Society, has grown from a simple survey of humpback whales in Antongil Bay to a multinational marine-mammal conservation effort. The CBC's work has led to the first legislation governing ecotourism and whale watching in Malagasy waters, providing protection for more than 1,000 humpbacks along their annual migration route. In Mainland Southeast Asia, the CBC is active in a suite of projects in Vietnam and Lao PDR (Laos) aimed at conserving the region's unique and globally significant biodiversity through an integrated program of research, education, and capacity building. These include species-based conservation efforts, the continued discovery of new species, training protected area staff in management techniques, and outreach.</p> <p>COLLECTIONS AMNH maintains scientific collections of over 32 million specimens and cultural artifacts, which constitute an irreplaceable record of life on Earth. The large holdings of AMNH are among the most important in the world in their depth and breadth and serve as one of the important international repositories for the study of comparative biology and biodiversity studies, geology, paleontology, and anthropology. Within the Museum's collections are many spectacular individual collections, from butterflies and spiders to dinosaurs and fossil mammals, from fishes, amphibians, and squamates to crocodilians and birds. They include meteorites, gems and minerals and cultural artifacts. Within the AMNH collection is a substantial number of type specimens. Type specimens, a concept used in both the geological and biological sciences, are the key reference specimens in those collections, and within</p>

Specimens serve as archives of biological and geological diversity that are preserved to assist in a comprehensive exploration of Nature. They continue to yield vast amounts of new information through direct observation and comparison, and, as new technologies emerge, through high-resolution imaging and analysis. These data are increasingly linked together by way of sophisticated informatics networks, accelerating research and applications for exploration. New technologies will reveal even more. The collections are made accessible for research on-site, on-line, and through loans to scientists around the world, continually adding to our knowledge and understanding. The Museum's extensive research loan program typically has over 1,500 active loans of over 300,000 specimens out to other institutions at any given time. The Museum further provides on-line access to its collections, with an estimated 95% of the non-entomology collections data-based and accessible on-line at this time. Institutions like the American Museum of Natural History are the key to advancing understanding of the history and diversity of life. Scientists estimate that the 1.7 million named species represent as little as ten percent of the species of animals, plants, and microorganisms on the planet and only a fraction of the historical legacy of fossil life preserved on Earth. To meet this challenge, AMNH continues to build its collections to allow ever more comprehensive comparisons and to promote scientific progress. While methods for collecting responsibly and sustainably have changed significantly in the past century, the Museum is currently in one of the most active collecting periods in its history. The collections grow at an average rate of over 90,000 specimens and artifacts annually. The Museum has also invested in new areas of scientific collecting - frozen tissue and digital data - in response to emerging research needs in genomics and astrophysics, and the availability of the newest technologies such as CT data and other digital imaging procedures. Preservation of these valuable collections for study by future generations and with new technological capacity has never been more important.</p> <p>RESEARCH LIBRARY The AMNH Research Library is one of the largest natural history libraries in the Western Hemisphere. Its primary purpose is to serve and support the work of the AMNH scientific staff, natural history scholars from around the world, and interested members of the general public. The Library's holdings comprise a research collection, special collections (including a rare book collection), and digital collections. Its catalogues are part of an international on-line library catalogue database that is available at public libraries and university libraries as well as through the AMNH website. Subject areas include anthropology, astronomy, geology, paleontology, zoology and, to some extent, the history of science and museology. This collection provides a continuous record of the literature of natural history dating back to the beginnings of Western science in the 15th century, and is particularly strong in the historical materials important to research in systematics. The Library print collection includes over 488,000 volumes of monographs, serials, pamphlets, government documents, maps, and original illustrations, and also includes the Rare Book and Folio Collections, comprising 11,550 items. The Rare Book collection is exceptionally comprehensive, with many works that are uniquely held and including early and significant works on natural history, major series on exploration, beautiful examples of various illustration processes, and many early bindings in leather, cloth, and paper. The Museum also has collections of 750,000 photographs and 7,000 reels of film and videos. The Library also provides many electronic resources through its on-line catalog and web site. Resources include the major indices as well as nearly 5,000 electronic journals in a wide range of subjects, received singly or through large collections. In addition, the Library has created various digital collections and web-accessible image databases that are accessible to the public.</p> <p>K-12 EDUCATION TEACHER PROFESSIONAL DEVELOPMENT PUBLIC PROGRAMS AMNH works closely with the formal K-12 education system to enrich school programs, train science teachers, and foster science literacy in New York City and across the country. AMNH is the number one field trip destination in New York City and, each year, more than 460,000 children visit in organized school and camp groups. Many more participate in programs that go beyond the Museum's walls. Professional development programs provide over 6,700 educators a year with content knowledge in science and social studies, many offering certificates of continuing professional education and credits toward advanced degrees in science.</p>

AMNH distributes its scientific publications, curriculum materials, and educational resource materials to schools, libraries, and community organizations through print publications and on-line and through partnerships with major educational publishers, such as Macmillan McGraw-Hill and Scholastic. Committed to lifelong learning, AMNH also offers programs, classes, and services fostering discovery, science literacy, and lifelong learning for audiences of all ages and backgrounds, both those able to visit AMNH and those far beyond its walls. The AMNH's education programs are delivered through the following centers:</p> <ul style="list-style-type: none">-The David S. and Ruth L. Gottesman Center for Science Teaching and Learning: AMNH feels a special responsibility to support and enrich the work of schools and is closely aligned to the public education system. This center provides a wide variety of programs to enhance school capacity by teaching schoolchildren, training teachers, and developing curriculum products that are tied to national science standards. Of the 460,000 schoolchildren visiting AMNH annually, approximately 190,000 or 29% of all New York City public elementary and middle school students visit free of charge on field trips each year. Instructors and volunteers guide groups through the halls and lead hands-on activities, and the AMNH provides comprehensive guides for teachers to prepare, conduct, follow up, and enrich their educational visits to the Museum. During 2006/2007 the Gottesman Center expanded its groundbreaking Urban Advantage program, a unique collaboration with seven other New York City science-based institutions and the New York City Department of Education to train science teachers and prepare approximately 15,000 7th and 8th grade students for their required science "Exit Project."-Other educational programs include after-school courses and the Moveable Museum program, customized, converted Winnebago vehicles outfitted as exhibition spaces with specimens, interactive computers, and exhibits, which carry AMNH content out to the schools and communities. The four Moveable Museums currently in the "fleet" are The Paleontology of Dinosaurs, Structures and Cultures, Discovering the Universe, and Dinosaurs: Ancient Fossils, New Discoveries.-National Center for Science Literacy, Education, and Technology: The National Center for Science Literacy, Education, and Technology was established in 1997 to design, produce, and distribute programs and materials using a range of technologies that includes software, video, web sites, and print publications. Its educational content is distributed to the public, K-12 science teachers and students, schools, and to families on-site and in their homes. The National Center's major content areas include:<ul style="list-style-type: none">-Resources for Learning- a comprehensive online resource for teachers,-OLogy- the AMNH award-winning web site for kids,-Seminars on Science- online professional development courses that help teachers meet the new national science standards that call for increased rigor and authentic, inquiry-based experiences for their students, and-Science Bulletins- multi-media news - and documentary - style updates on the topics of biodiversity, Earth sciences, astronomy, and human biology, evolution and genetics, which bring updated science into the Museum's halls and to subscribing museums and science centers nationwide.-Center for Lifelong Learning: AMNH offers a broad array of programs throughout the year for adult and family audiences. Lectures, curator talks, performances, classes, tours, and workshops complement and extend the themes of special exhibitions. The Margaret Mead Film & Video Festival, presented each fall, is the world's oldest documentary film festival and features films from around the world. Cultural programs are presented throughout the year and are geared to family audiences. They include performances, workshops, films, and classes. Annual cultural events include Black History Month programs, Kwanzaa, and the Living in America series, which celebrates the culture and arts of a different ethnic group each year. Programs for youth and families include the Science and Nature Program, which offers hands-on science activities for pre-school children and their parents or caregivers. Options for older children include on-site, after-school courses that introduce students to many branches of science, including biodiversity, Earth science, anthropology, genetics, and astronomy. AMNH also offers internships and intensive year-long (or multi-year) research experiences for New York City high school students.
