Sky Hunters' continued to pursue our mission of teaching awareness and respect for wildlife and wild places in 2007. We have completed our third full year of operation and have provided 100 paid presentations, 14 free presentations, and participated in 6 environmental educational booths during the year. We reached approximately 6,200 school children in 2007, mainly in Santa Clara and San Mateo counties. Adult and mixed age group public presentations reached an additional 2,700 people. Presentations are generally an hour in length and focus on natural history and the importance of wildlife in our communities.
