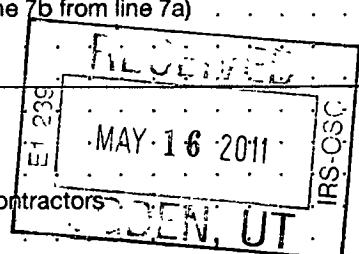

Part III Statement of Program Service Accomplishments

DV LEAP provides a stronger voice for justice by fighting to overturn unjust trial court outcomes, advancing legal protections for victims of domestic violence and their children through expert appellate advocacy, training lawyers, psychologists and judges on best practices, and spearheading domestic violence litigation in the Supreme Court.

Exempt Purpose Achievements:

DC LEAP: DC LEAP represents parties and friends-of-the-court in civil and criminal appeals concerning domestic violence in D.C. DC LEAP also provides consultations, trainings, and resources to local domestic violence attorneys, advocates and survivors; assists the domestic violence community with legislative reforms; and has established formal collaborations with the U.S. Attorney's Office and the Office of the Attorney General of D.C. to support their advocacy on behalf of victims of abuse in criminal cases.

Rights Litigation Project: Files friend-of-the-court briefs in Supreme Court cases concerning domestic violence; delivers public presentations and trainings to national and local advocates; concerned citizens, and attorneys; and publishes articles regarding the Supreme Court's confrontation clause jurisprudence and other constitutional rights issues.

Custody and Abuse Project: Litigates selected cases involving custody and abuse; provides consultation to victims of abuse and their attorneys fighting to keep children safe through the courts; conducts trainings and presentations around the country; engages in law reform efforts; and publishes articles and research summaries to help those seeking to protect child and adult victims of abuse.

All States Litigation Project: Litigates appellate cases in other states involving significant domestic violence issues, provides trainings and consultations on a variety of domestic violence topics, and assists in law reform work in other states and national fora.
