The Show-Me Institute commissioned and published two studies by outside scholars, and staff and scholars of the Institute researched and wrote fourteen studies, fifty-seven (57) commentaries and 537 blog posts, related to various topics including education, states taxes, and Missouri's economic growth. The studies were made available to the public in print form, commentaries were published in newspapers, and all studies, commentaries and blog posts are made available to the public online.

Throughout Missouri, the Show-Me Institute hosted lectures and seminars, participated in public events, and appeared in numerous media outlets, i.e., radio and television, to present its research findings to local and state nonprofit, legislative, media, and citizen groups. With respect to lectures and seminars, the Institute co-sponsored seven (7) lectures by scholars - four (4) in Kansas City and three (3) in St. Louis, and sponsored four (4) breakfast forums in Columbia, five (5) in St. Louis, three (3) in Kansas City, and one (1) in Springfield.
