IN ADDITION TO ITS EDUCATIONAL PROGRAMS, THE BAUM SCHOOL OF ART'S DAVID E. RODALE AND RODALE FAMILY GALLERIES HOLD 12-14 GALLERY EXHIBITIONS A YEAR AND FEATURE REGIONAL, NATIONAL, AND INTERNATIONAL ARTISTS, AS WELL AS STUDENT WORK AND MULTIPLE JURIED EXHIBITIONS.
