WE ORGANIZE THE GENOMES, ENVIRONMENTS AND TRAITS (GET) CONFERENCE, WHERE WE INVITE LEADING THINKERS TO DISCUSS THE IMPORTANT WAYS IN WHICH NEW GENOMIC TECHNOLOGIES WILL AFFECT ALL OF OUR LIVES IN THE COMING YEARS AND TO DEBATE THEIR TECHNICAL, COMMERCIAL, AND SOCIETAL IMPACTS.
