GORILLA WELFARE - A PROGRAM TO PROVIDE FOR THE CARE AND WELL-BEING OF THE PARK'S LOWLAND AND MOUNTAIN GORILLA POPULATIONS. IN 2017, WORK BEGAN TO ESTABLISH A SANCTUARY FOR LOWLAND GORILLAS AND IMPROVED SECURITY IN THE MT TSHIABERIMU REGION. THE WORK HAD TO BE TEMPORARILY SUSPENDED DUE TO INSECURITY IN THE REGION BUT HAS SINCE RESTARTED. THE PARK RECORDED ITS SECOND YEAR WITH NO UNNATURAL DEATHS OF MOUNTAIN GORILLA WIDOWS SUPPORT - A PROGRAM ESTABLISHED TO PROVIDE SUPPORT TO THE WIDOWS AND ORPHANS OF PARK RANGERS KILLED IN THE LINE OF DUTY.
