WE HELP PARENTS TO UNDERSTAND THE EMOTIONS AND BEHAVIORS OF THEIR CHILDREN FROM A DEVELOPMENTAL PERSPECTIVE AND HELP THEM REALIZE THAT HEALTHY PARENT-CHILD BONDS ARE AN ESSENTIAL COMPONENT TO FUTURE DECISIONS AND RELATIONSHIPS. CHILDREN "FIND THEIR VOICE" DURING OUR PROGRAMS AND ARE ABLE TO TALK ABOUT THEIR THOUGHTS AND FEELINGS. WE ARE INCREASING SELF-ESTEEM AND HELPING CHILDREN TO HAVE POSITIVE RELATIONSHIPS WITH BOTH THEIR PARENTS.
