Human Capital Pipelines/Talent Management The Fund was one of the first in the nation to identify talent as the critical lever to improving schools. As we closed our second Fund and launched our third in 2008, our focus nevertheless remained steady on human capital. We continued seed funding for a premier principal preparation program managed by Teach for America and the Harvard Graduate School of Education, as well as a Principal Pipeline Program and School Leadership Recruiter at Chicago Public Schools that bring internal and external principal candidates toward preparation and eligibility in Chicago. We also seeded the first national advanced certificate for principals, in partnership with the National Board for Professional Teaching Standards, which will pilot its certificate partially in Chicago after the development phase. Finally, The Fund substantially met its goal of 1,200 teachers in Chicago achieving National Board Certification and we paid out our last financial incentives to those teachers for earning the highest distinction in the teaching profession.

Differentiated Compensation The Fund believes compensating people more for doing more and achieving more is part and parcel of any well-run organization. The Fund is spearheading differentiated compensation in Chicago as a means to elevate the performance of talent in schools. We believe that compensation should be based on a blend of student performance, job responsibilities, and objective measures of job skills and knowledge. In 2008, The Fund reinvested in and continued to scale the Chicago Teacher Advancement Program, which is a comprehensive model of professional supports (involving greater mentoring, feedback and job-embedded professional development for faculty) and performance-based bonuses. The pilot program, which is also funded by the federal Teacher Incentive Fund and redirected Chicago Public Schools dollars, is currently in 20 schools and will reach 40 schools by 2011.
