Part III, line 28 - \$81,861 - (USD equivalent) program expenses for AIDS prevention and youth development in South Africa and Swaziland in

schools, detention centers, and community and church groups. The goal is to educate youth about HIV and how to avoid it, and to teach all

youth (whether HIV negative or positive) how to make wise life choices. The program is taking place in the South African provinces of

Gauteng, KwaZulu-Natal, North West, and Western Cape, and in Swaziland. Indigenous young adults from the local communities

serve in schools as teachers (peer educators - young adults working with young people). The program also benefits the peer educators

educators as they gain confidence and job skills. In 2016, with the help of 39 Peer Educators and additional volunteers, 72,965 students

participated in Reach4Life assemblies, and small groups. Of the \$81,865 in expenses, \$79,756 (USD equivalent) was paid from

Part III, line 29 - \$25,454 - A mission team of 14 people from five US churches spent two weeks in the Gauteng (Johannesburg), North West, and Western Cape (Cape Town) provinces, teaching the R4L program in twelve schools. The team also worked in a juvenile detention center, did several kids' clubs, met in men's and women's groups, visited an elder care facility, and worked with local churches to do home visits and distribute food parcels in the community. Mission trips take place approximately every other year and are funded solely by the team members; no Prevention Time general funds are used. This makes revenue appear much higher in those years since mission funding is included as revenue, but is actually outside of our normal program revenue and expenses.

Part III, line 30 - \$16,429 - Funding for 10,000 Reach4Life books(\$15,000) was given to Biblica US, and another \$1,429 was given to Biblica South Africa to arrange for the book deliveries in Africa. These books contain curriculum for the AIDS prevention and youth development program taught in schools.

Part III, line 31 - \$9,290 grant was given to Khayelisha Care, P.O. Box 310, Tugela Ferry, 3010, South Africa, a care center for orphans and and vulnerable children. Our support is in the form of child sponsorships and general funding of the center, which provides palliative care, foster housing, and basic needs for children in the community.
