## **Minnesota Coalition for Battered Women MCBW Fiscal Year 2014 Key Accomplishments**

The Minnesota Coalition for Battered Women has successfully completed all FY2014 goals and activities as put forth in grant agreements and through the agency's work plan. The Coalition works to improve the lives of battered women and their families through public awareness, public policy and increasing the capacity of those who work directly with domestic violence victims.

Key accomplishments during FY14 included:

### **Public Awareness:**

- MCBW has expanded the Live Violence Free flag campaign. The flag campaign is connected to MCBW's Domestic Violence Femicide Report. Each time there is a domestic violence homicide in Minnesota, participants in the flag campaign are notified via email and asked to display the flag image for one week as a way to increase public awareness and promote education in local communities. Over 400 individual yard signs, flags, and banners are distributed to organizations and individuals who are participating in the awareness campaign. This includes educational institutions, churches, business, law enforcement as well as domestic violence organizations. Others, not formally part of the campaign, participate by using social medial images to promote the campaign.
- MCBW created and launched the "Real Love Is..." campaign with youth. This social media campaign was taken up by youth organizations around the state. A contest, sponsored by Verizon Wireless, awarded three youth organizations prize money for their winning campaigns. The campaign will be expanded upon during fiscal year 2015.
- Three years ago, MCBW began the Domestic Violence Homicide Memorial Event. Last year over 180 people attended this event which includes policy makers, family and friends of homicide victims and advocates. The event is held on the same day that the annual Femicide Report is released. The annual Clothesline Project memorial art display is unveiled at the event.
- Action Day at the Capitol was held and included training, networking, educational meetings with legislators and specific youth events. The Day culminated with a Rally held in the Capitol's rotunda.

### **Public Policy**

- MCBW worked for a second year on Project Connect which is focused on increasing the skills of health clinic practitioners to screen for, respond to and make referrals around teen sexual and dating violence issues. The project activities included training, policy creation and networking.
- MCBW worked on a Minnesota Appellate Court case involving the Safe at Home, address confidentiality program. MCBW's position was upheld by the appeals court and the confidentiality of program participants was maintained.
- MCBW worked with membership to continue to do education of policy makers.
- MCBW convenes and leads a statewide collaborative effort within the criminal justice system. This collaborative was expanded to include Dept of Corrections. MCBW also was the first

program in the country to receive federal government GTEA funding to work with the Dept of Corrections on victim safety issues.

#### Capacity Building for Service Providers

- MCBW maintained a strong training program conducting monthly webinars for member programs, conducting in person training for membership and responding to issue specific training requests.
- MCBW completed the Impact Initiative discussion process that was funded by Butler Family Foundation. That discussion process is being expanded to a year-long strategic planning process for the entire domestic violence field in Minnesota.
- MCBW continues to assist multiple member programs as they experience leadership transitions.
- Regional membership meetings are held at six locations in the state every quarter. The fall quarter is when MCBW hosts the Annual Membership Meeting – a 1 ½ day meeting where member programs share information, set MCBW's priorities for the coming year and network.
