We launched the Emotion Revolution survey in partnership with the Yale Center for Emotional Intelligence, asking high school students how they currently feel within their schools and how they like to feel within their schools We received over 44,000 responses and created an overview of the findings, distributed more broadly through our Emotion Revolution Summit and online On October 24, 2015 we convened more than 400 students, educators, non-profit leaders and policy makes to have conversations about the findings of the survey and work collaboratively to create plans to build kinder and braver schools
