The organization is an FCC licensee for nine NCE (noncommercial-educational) radio stations. The FCC regulates the licensee by a reporting and renewal process to insure that it provides programming in the public interest, convenience and necessity. The nonentertainment programming is a broad range from three foreign language programs to public high school athletic events, to emergency information.

The broadcasting of noncommercial educational material as described in #1 is the "accomplishment." It is not possible to peel away "other" accomplishments.
