As a licensee of ten noncommercial/educational licenses from the FCC, it broadcasts free over the air educational, cultural, public affairs and scientific audio content. Support is raised in over the air appeals from listeners. No products are sold or offered as an incentive to donate.

The organization is regulated by the FCC via a license renewal process to insure that it provides programming in the public interest, convenience and necessity. An example of that meets these accomplishments include broadcasting public high school sports events weekly. It has been ascertained that the public school system is under served by commercial radio. Year around sports covered include girls softball, girls and boys basketball, high school football, and little league during the off-school months of summer.

4b (Code) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

The organization is regulated by the FCC via a license renewal process to insure that it provides programming in the public interest, convenience and necessity. An example of that meets these accomplishments include German language and German music weekly, including news from Germany intended for German Americans in the community. A similar Polish cultural program completes the 90 minute weekly broadcast that is in it's 32nd year. Hosts are retired volunteers.

The organization is regulated by the FCC via a license renewal process to insure that it provides programming in the public interest, convenience and necessity. An example of that meets these accomplishments include Emergency Management and local authorities have written consent to preempt at any time for messages relating to hurricane damage and preparedness.
