The King Center continued to offer a wide and eclectic variety of programming that included many categories and genres of programs that represents our community interest. During fiscal year 2008-2009 the center offered 60 main stage programs, distributing over 105,000 tickets.

The Educational Theatre Program offered 10 mainstage programs during fiscal year 2008-2009 and distributed nearly 19,000 tickets. To improve and expand the community outreach of these programs, the ETP continues to cultivate younger audiences with a twenty-something focus group. Additionally, the ETP is working to develop new marketing strategies with these groups to attract potential new audiences while maintaining current relationships with local arts organizations and the Brevard County School System
