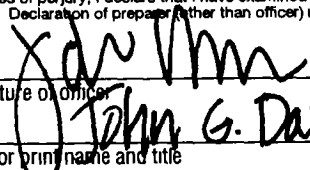
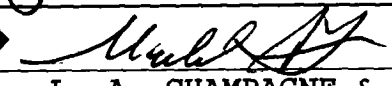

Selection criteria, approved by the Foundation, may include academic performance, financial need, stated goals, or areas of interest. Independent selection committees appointed by the Foundation award scholarships on a competitive basis. Appropriate records are maintained on each application, award, and verification of continuing eligibility. Scholarship checks are written jointly to both the recipient and the education institution to insure proper distribution of the proceeds.

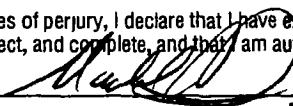
