WLCV Institute worked to enhance the capacity of the conservation movement in Wisconsin by connecting conservation-minded citizens with the policy-making process through education, advocacy, public opinion research, and the implementation of voter participation techniques. In 2015-2016 the Institute educated and mobilized citizens in support of the Knowles Nelson Stewardship program and funding for county conservationists, and against a bill that would have granted "forever permits" to major water users whose consumption of vast amounts of water threatens lakes, rivers, and drinking water. In addition, WLCV Institute worked to educate Native Americans about voting laws and encourage them to vote.
