IN ORDER TO ALLEVIATE THE RISK OF THESE PENALTIES, THE ORGANIZATION IS FILING FORM 5713 ALTHOUGH IT DOES NOT BELIEVE THE ACTIVITIES DESCRIBED PREVIOUSLY SHOULD RISE TO THE LEVEL OF BEING CONSIDERED "OPERATIONS" IN THESE COUNTRIES.
