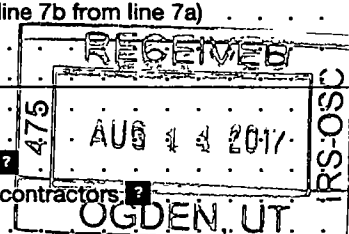

Educational Purpose Our educational purpose is two-fold, (1) continuing education for our membership and (2) educating the community at large on the earth sciences in general and mineral identification, rockhounding, lapidary arts, silversmithing and related metal working, lost-wax casting, hard-stone carving, flint knapping, wire-wrapping, beading and micromounting.

Jackpot of Gems

In 2016, the Society hosted its 51st annual "Jackpot of Gems Show". The goals of this annual show are to educate the general public about rocks, minerals, fossils and the Earth Sciences, and to bring together interested parties to share ideas, techniques and knowledge about these subjects. There are exhibits of rocks, minerals, fossils, lapidary work and lapidary based artworks. Organizations such as the Nevada Bureau of Mines and Geology at the University of Nevada, the Nevada Department of Minerals, The Friends of the Black Rock and other Earth science based organizations participate. Demonstrations of lapidary work and related art production are provided by members and outside parties.

Classes

Classes are offered in our facilities to members on a weekly basis, in our community and throughout the West, including mineral identification, rockhounding, lapidary arts, silversmithing and metal working, lost-wax casting, hard-stone carving, flint knapping, wire-wrapping, beading and micromounting. These classes are taught by member volunteers, some of whom are master-level teachers. Many of these classes involve and are taught utilizing facilities and equipment that is beyond the financial reach of individual members on their own. To further the teaching-learning experience, a multi-media library is maintained and made available to members. Formal classroom instruction by our member-instructors exceeds 1,200 service hours per year. Attendance at monthly meetings and related instructional programs usually exceeds 100 persons. Class attendance ranges from four to fifty persons per day, depending on the particular subject and venue.

Community Events

Member volunteers provide rotating monthly exhibits at regional libraries, displays and narrated presentations at schools and senior centers, merit badge classes for Girl and Boy Scout troops, and demonstrations and classes for Boys and Girls Clubs and other organizations upon request. Several thousand persons benefited directly from these presentations. Approximately 1,200 volunteer hours are provided annually toward these events.
