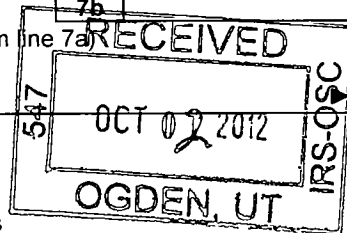

used clothing, appliances, and furniture with the intention of benefitting our
organization. Indirectly, therefore, this revenue is a form of public support. If our
royalties are recognized as public support then the percentage from public support is
100%.
