In 2013, Children's Rights was engaged in litigation to reform the failing child welfare system of Massachusetts, Rhode Island and Texas. The organization was also monitoring progress in nine states where it has already won substantial reform: Oklahoma, Michigan, Mississippi, Tennessee, metro Atlanta (Georgia), Connecticut, New Jersey, Milwaukee (Wisconsin), and Washington DC. The organization will remain involved in all these states to achieve measurable results for the thousands of vulnerable children in foster care.
