If a board member, committee member or officer has an interest in a proposed transaction with the organization in the form of a significant personal or organizational financial interest in the transaction or holds a position as trustee, director, officer, or staff member in such organization, he or she must make full disclosure of such interest in writing before any discussion or negotiation of such transaction. Any board member, committee member or staff member who has a potential conflict of interest with respect to any matter coming before the board or a committee shall not participate in any discussion of or vote in connection with the matter unless invited to respond to questions or requested to provide factual information by the board or committee chair.</p>
