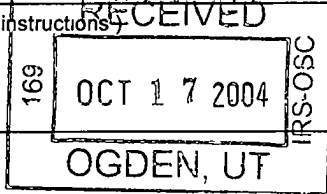

BASED ON BIBLICAL PRINCIPLES, THE BUSINESS MEN AND WOMEN ARE TAUGHT TO ACT AND CONDUCT THEMSELVES, BOTH PROFESSIONALLY AND INDIVIDUALLY, IN A MANNER THAT GLORIFIES GOD.
