Intake, Shelter, Foster and Adoption Programs GPG takes in stray and surrendered animals from residents in the East St. Louis and surrounding communities. These include Alorton, Cahokia, Washington Park and Centreville. These communities' homeless animals make up 25% of the intake into our local municipal shelter. As part of our goal to end homelessness for animals in these communities, we also transfer animals that came in from these areas from St. Clair County Animal Services. GPG took in over 380 animals from these communities and AC in 2018. These programs are supported by staff and volunteers. 112 foster families were added in 2018 to increase our capacity for care for rescued animals. And over 2500 hours of volunteer help assisted staff in shelter animal care. 817 animal movements were also managed by program staff and volunteers. In addition, 443 animals were adopted to their forever families.

---

### **Form 990, Part III, Line 4b:**

Community Program At GPG, we firmly believe that every family should be able to have the companionship of a pet even if they have financial restrictions. In 2018, 924 calls were answered on our community line from families and individual seeking support. Because the community we serve is a pet resource desert with no veterinarian or pet store, our staff and volunteers provide assistance to families to not only help them keep their pet during unstable times but also provide veterinary care that the community is lacking. 331 animals were spayed/neutered, 524 animals received life-saving vaccines and 330 animals received microchips. In addition, 238 community cats were sterilized and 71 animals received emergency vetting during a time of crisis. All of these efforts over the past five years have helped us drastically reduce the number of animals entering our municipal shelter and wondering the streets.
