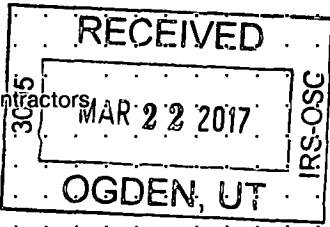



Give to the World provides essential materials to desperate people living in conflict zones all around the world. We undertake distribution overseas directly or through legitimate partners, empowering the local populace with critical medicines, medical supplies and equipment that helps to address the underlying cause of instability. By saving lives and alleviating suffering, Give to the World's work provides the foundation for follow-on stabilization through economic, political and social development. To maximize our impact we work with key local leaders to ensure that these materials are distributed to the populations in greatest need.

Background:

Give to the World started in Afghanistan by providing blankets, shoes and clothing to locals in the greatest need. The work helped some of the most impoverished people in the world to endure the harshest conditions. Since our inception as an NGO in Afghanistan, we expanded our assistance to other conflict and post conflict areas of the world to include East Africa, the Middle East, Southwest Asia and war torn areas of South America. Many of these areas remain untouched by traditional NGO's, who find it too difficult to access these parts of the world. Given that our suppliers of humanitarian aid are genuinely concerned with our mission and those we serve, the wholesale average cost of the materials provided by them far exceeds the purchase price Give to the World is charged.
