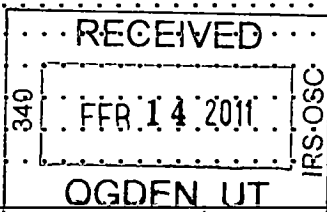





Surfing's Evolution & Preservation Foundation is organized, and will operate for the purpose of ensuring the preservation of the history of surfing as a sport and recreational activity and the preservation of surfing as a recreational activity as well as the preservation of the beaches and the environment. The organization will also educate the general public regarding all of these activities, as well as concerning beach safety, coastal pollution and beach ecology. This education will take the form of the publication of articles, holding of forums and events, and such other activities as determined from time to time by the Board of Directors. The organization also will fund and support lifeguards for high risk beaches to aid in the protection of the public utilizing such beaches, and the development of artificial reefs and other environmentally friendly activities; if such activities are similar to or associated with the organization's activities, and if such activities are also exempt under Section 501(c)(3) of the Code and the applicable rules and regulations thereunder. The organization, through its Board of Directors, also will develop and fund other programs and activities designed to assist in preserving and protecting the shoreline and the delicate ecosystems residing there.
