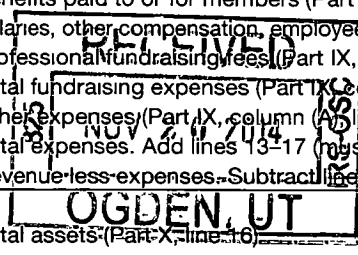

The foundation achieved its program service objectives this tax year, through the production of the Viva Florida 500 Tall Ship Event, May 1-12, 2013 and the Melbourne Air and Space Show, November 3, 2013. The Viva Florida 500 Tall Ship event in Port Canaveral, FL, celebrated Florida's 500th Anniversary. Event program theme of "First Step to First Step" from Ponce de Leon discovering Florida to Neil Armstrong landing on the Moon educated over 10,000 people on the history of early sea exploration and current day space exploration. The Foundation's Future Explorers Education Program provided a hands-on learning experience to 3,600 public school 4th and 5th grade students. The Second Event, the Melbourne Air and Space Show, November 3, 2013, a waterfront aviation event with a diverse representation of civilian aviation aircraft educating over 25,000 spectators about the opportunities in the growing aerospace industry in Melbourne and showcased expert pilot skills and how STEM-based disciplines can lead to a career in the industry.**
