ANNUALLY, THE APPLICABLE INDIVIDUALS ARE REQUIRED TO SIGN A CONFLICT OF INTEREST STATEMENT WHICH AFFIRMS THAT THEY HAVE RECEIVED A COPY OF THE CONFLICT OF INTEREST POLICY, HAS READ AND UNDERSTANDS THE POLICY, HAS AGREED TO COMPLY WITH THE POLICY, AND DISCLOSE ANY ACTUAL OR POTENTIAL CONFLICTS. IF A CONFLICT WERE TO ARISE, THE EXECUTIVE COMMITTEE OF THE BOARD WOULD REVIEW AND TAKE APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION. IF A CONFLICT ARISES DURING ANY GIVEN YEAR, THE BOARD MEMBER IS REQUIRED TO RAISE THE CONFLICT TO THE PRESIDENT AND THE EXECUTIVE DIRECTOR IN WRITING. IF A MEMBER FEELS THAT ANOTHER MEMBER MAY HAVE A CONFLICT, THEY ARE ALSO REQUIRED TO RAISE THE CONFLICT TO THE PRESIDENT AND EXECUTIVE DIRECTOR IN WRITING. IF THE MEMBER DOES NOT AGREE THAT THEY HAVE A CONFLICT, IT IS BROUGHT TO THE FULL BOARD TO VOTE AND DETERMINE IF IT IS INDEED A CONFLICT. ONCE A MEMBER DECLARES OR HAS BEEN FOUND TO HAVE A CONFLICT, THAT MEMBER MAY NO LONGER PARTICIPATE IN ANY DISCUSSION OR VOTE ON ANY MATTER PERTAINING TO THE CONFLICT. THE MINUTES OF THE BOARD AND COMMITTEE MEETINGS SHALL DOCUMENT THE NAMES OF THE PERSONS WHO DISCLOSED OR WERE FOUND TO HAVE CONFLICTS, THE NATURE OF THE CONFLICT, AND THE BOARD'S DECISION REGARDING THE CONFLICT.

THE ORGANIZATION DOES NOT HAVE OTHER OFFICERS OR KEY EMPLOYEES AT THIS TIME, HOWEVER IF THIS SHOULD CHANGE, A PROCESS SIMILAR TO HOW THE EXECUTIVE DIRECTOR'S SALARY IS DETERMINED WOULD BE ADOPTED BY THE ORGANIZATION.
