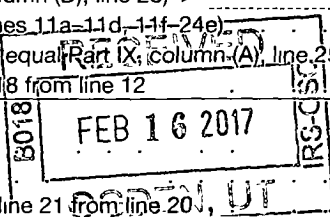

Shen Yun performances bring stories alive on stage through the classical Chinese dances, folk and ethnic dances, opera singing, and live orchestra
