FINANCIAL ASSISTANCE - IN 2014 JFCS PROVIDED FINANCIAL ASSISTANCE TO 238 INDIVIDUALS, RANGING IN AGE FROM 6 TO 102. THE GOAL OF THE JFCS FINANCIAL ASSISTANCE PROGRAM IS TO PREVENT HOMELESSNESS AND HUNGER. JFCS STRIVES TO PREVENT HOMELESSNESS BY PAYING, ON AN EMERGENCY BASIS, RENT, MORTGAGE PAYMENTS AND UTILITIES. A JFCS CASE MANAGER WORKS WITH FINANCIAL ASSISTANCE INDIVIDUALS AND FAMILIES TO HELP THEM MAKE CHANGES IN THEIR SITUATIONS AND BECOME INDEPENDENT. ALL BILLS ARE PAID DIRECTLY TO THE VENDOR AND NO MONEY IS GIVEN DIRECTLY TO A CLIENT. TO ADDRESS ISSUES OF HUNGER AND FOOD INSECURITY JFCS HAS A FOOD PANTRY THAT SERVES APPROXIMATELY 70 INDIVIDUALS EACH MONTH. JFCS PROVIDES MONTHLY GIFT CARDS TO THE LOCAL SUPERMARKET SO THAT FRESH FRUITS AND VEGETABLES CAN BE PURCHASED TO SUPPLEMENT THE CANNED AND BOXED FOOD THAT IS AVAILABLE THROUGH THE JFCS FOOD PANTRY.

SENIOR CENTER - ON JANUARY 22, 2014 JFCS OPENED THE FIRST SENIOR CENTER IN COLLIER COUNTY. OPEN TO ALL DENOMINATIONS OF ADULTS AGE 60 YEARS AND OLDER, THE NAPLES SENIOR CENTER HELPS SENIORS MAINTAIN A HEALTHY, SATISFYING QUALITY OF LIFE BY PROVIDING SERVICES AND ACTIVITIES IN A NURTURING ENVIRONMENT. THESE ACTIVITIES ALSO ENABLE SENIORS TO FUNCTION MORE INDEPENDENTLY IN THE COMMUNITY. ON DECEMBER 31, 2014, THERE WERE 510 MEMBERS OF THE SENIOR CENTER. MEMBERSHIP IS REPRESENTATIVE OF ALL RACES AND RELIGIONS. MANY ARE PHYSICALLY FRAIL. WHAT THEY ALL HAVE IN COMMON IS A NEED FOR ASSISTANCE IN SOCIALIZATION TO ADDRESS THEIR ISOLATIONS AND FEELINGS OF LONELINESS. THE NAPLES SENIOR CENTER IS OPEN 5 DAYS A WEEK OFFERING A WEEKLY HOT LUNCH AND ENTERTAINMENT, ART CLASSES, COMPUTER INSTRUCTION, LECTURES, CARDS, DISCUSSION GROUPS AND EXERCISE.

MENTAL HEALTH SERVICES - IN 2014 JFCS PROVIDED MENTAL HEALTH SERVICES TO 168 INDIVIDUALS BETWEEN THE AGES OF 5 AND 98. SERVICES INCLUDED INDIVIDUAL, COUPLE, FAMILY AND GROUP THERAPY PROVIDED BY A FLORIDA LICENSED CLINICAL SOCIAL WORKER. SERVICES ARE AVAILABLE TO EVERYONE IN THE COMMUNITY REGARDLESS OF ABILITY TO PAY. FEES ARE CHARGED ON AN INCOME-BASED SLIDING SCALE. ISSUES FACED BY CLIENTS SEEKING MENTAL HEALTH COUNSELING FROM JFCS INCLUDE DEPRESSION, ANXIETY, LIFE-CYCLE ISSUES RELATED TO GRIEF AND LOSS, PARENTING, SEPARATION OR DIVORCE AND RELATIONSHIP ISSUES. IN MOST CASES A SHORT-TERM THERAPY MODEL IS USED, WHERE GOALS AND OBJECTIVES ARE CLEARLY ESTABLISHED.
