The Center received 501(c)(3) designation on March 9, 2015. At that time, we were providing overnight shelter to the homeless population of Denton during periods of inclement weather. We were using the facility at a local church until March 2015 when we moved to the City of Denton's former animal shelter. In the fall of 2015, we signed a lease with the City for long term use of the facility. On sheltering nights, clients were provided with an evening meal, a place to sleep, guidance and referrals to local service agencies. All of these services were provided by volunteers. The Center has no paid staff. Sheltering was interrupted between September and December 2015 while the building was brought into compliance with the City's fire code. Sheltering resumed on December 24, 2015 and has continued. During 2015, we provided overnight sheltering on approximately 88 nights with clients per night ranging from 22 to 44. Our services now include shelter two nights per week, regardless of weather as well as AA meetings and expansion of collaboration with other agencies and referrals.
