The FCC regulates the licensee by a reporting and renewal process to insure that it provides programming in the public interest, convenience and necessity. The nonentertainment programming is a broad range from three foreign language programs to public high school athletic events, to emergency information.

 The broadcasting of noncommercial educational material as described in #1 is the "accomplishment." It is not possible to peel away "other" accomplishments.

 Program service accomplishments are a composite effort to provide noncommercial educational programming to the public on the FCC Reserved Channels (FM - frequencies allocated for noncommercial educational use).
