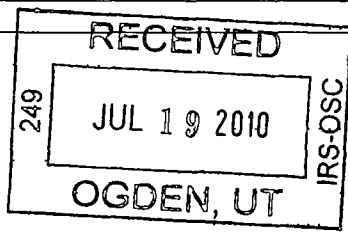



TO PROVIDE ADMINISTRATION AND OVERSIGHT IN THE DEVELOPMENT AND SOLIDIFICATION OF SOCCER CLUBS IN AND AROUND BREVARD AND SURROUNDING COUNTIES INTO A SINGLE LEAGUE THAT SHALL BE AFFILIATED WITH FLORIDA YOUTH SOCCER ASSOCIATION.
