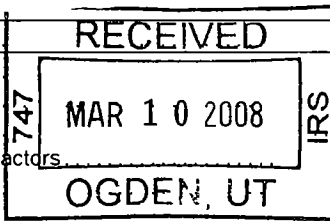

This is accomplished through activities such as the Fall Festival, Holiday Shop, Movie Night, and Parent/Child Nights, which provides entertainment, community involvement and family interaction, while raising funds for school programs, supplies, equipment and other items needed by the school. The PTO is currently trying to raise funds to cover the cost of upgrading the schools' technology (approx \$30,000). It is expected to be completed in the next school year.
