

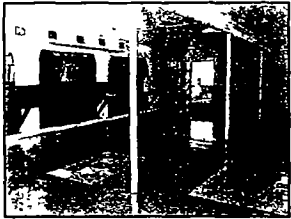

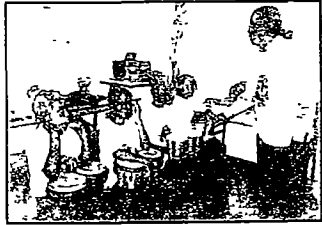

In the summer of 1998, a group of concerned Christians, under the leadership of teacher and spiritual leader Janet Marks, met and prayed about a problem they were encountering on the streets of South Melbourne, Florida. Children were roaming the neighborhood, unsupervised – sometimes even in the evenings after dark.

These concerned Christians organized an After-School Program for the children at the Full Gospel Deliverance Church. In order to expand this program a small house at 2411 Lipscomb Street, which had been a hub for drug transactions, was purchased.

People from churches and organizations in South Brevard County united to help renovate the house so that it could evolve into a safe, loving and caring environment, now known as "The Master's Workshop." Due to lack of space, an additional facility on University Boulevard was rented and a center opened there in January of 2003.

In July of 2004, The Master's Workshop purchased the 'Blues Lounge', a 4,000-square-foot building, for the purpose of transforming the dilapidated facility into a secure and safe haven for its programs and providing a replacement for the two former locations.

Our program reaches culturally diverse, at-risk youth (ages 3 to teens) in the Melbourne/Palm Bay area. Our after-school activities include homework help, tutoring, music, computer, arts & crafts and nutritional awareness. A meal is served to the children each afternoon.

**Our programs are held from Monday to Friday, after school hours and on Sundays. Special programs are held on Saturdays. Transportation is provided. Adult helpers are needed each and every day.**

In 2002, The Master's Workshop was incorporated in the State of Florida as a non-profit Corporation under Section 501(c)(3) and is exempt from federal income tax.

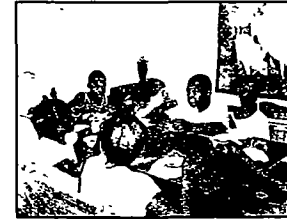

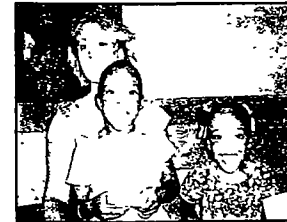
