Scholarships - The Washington State Potato Foundation awarded scholarships for the 13th consecutive year. A total of 50 applicants applied for scholarship funds (up from last year by 9%), the highest number of applications ever received. The quality of applicants was exceptional and 47 of the 50 students received awards (an increase of 24%). Awards ranged from \$500-\$5,000. Only one Ag Ambassador (top award of \$5,000) was selected this year.

Grower Education - The Foundation offers a host of educational workshops, seminars, pesticide certifications, first aid trainings, field day, lectures, and workshops that benefit the 300 plus growers throughout Washington state. Field Day features field tours highlighting the latest research developments in potato growing practices and pest management, as well as water and nutrient use efficiency trials of several new potato cultivars (new varieties) and a host of educational seminars. The Foundation supports this program by sponsoring the lunch for more than 350+ growers from throughout the region that attend this half-day seminar. This event has been taking place for over 50 years and the Foundation has been a partner in supporting this event since it was established in 2000. First aid classes were also offered in both English and Spanish for nearly 60 recipients from the potato growing industry.

Industry Leadership Banquet - The WSPF Industry Leadership Banquet was hosted on January 30, 2013 at the Red Lion Inn located in Kennewick, Washington. Nominations were received to honor a host of great leaders in the region and an award ceremony celebrated past and present leaders, as well as a current agriculture students. Each year attendance continues to grow with nearly 330 people in attendance.
