The basic mission of the Receiving Home provides hope and healing for children and their families who suffer from the effects of abuse and neglect. The children that reside here have been abused, molested, neglected, abandoned, or have families who are otherwise unable to provide for them. The children in the program are all under the auspices of the Department of Health and Human Services and the Superior Court. Most of the children are brought here by law enforcement at the request of Child Protective Services, and for the majority of the children, it is the first time they have been removed from their homes and families. After care and services, children and youth leaving the facility may return home or they may be placed with relatives, foster homes, or other residential centers. The process of finding new homes is supported by CRH staff with pre-placement visit to ensure comfortable and smooth transitions.

Residential Services - The facility is licensed annually by the State Department of Social Services to provide care for 90 children ages 1 to 18. The Children's Receiving Home is available twenty-four hours a day, seven days a week, for the admission of children and serves between 1,000 and 1,200 children a year. Children are in crisis when they are admitted to this facility, and our objective is to be as supportive and constructive as possible during their stay here. Clinical Services - The Children's Receiving Home's Mental Health Program consists of two program components and is funded through a contract with Sacramento County Mental Health utilizing Early Periodic Screening, Diagnosis and Treatment (EPSDT) funding. EPSDT is the child health component of Medicaid. It is required in every state and is designed to improve the health of low-income children, by financing appropriate and necessary pediatric services. Independent Living - The Independent Living Program at the Children's Receiving Home of Sacramento (CRH) is a youth-centered, individualized, results oriented program designed specifically to assist emancipating foster youth on a path of successful transition from the foster care system and into adulthood. Youth are assisted in developing sufficient independent living skills prior to emancipation followed by a similar post-emancipation component focused on their needs after they turn 18 years of age. Residentially Based Services - The Children's Receiving Home is one of three agencies selected to participate in the Residentially Based Services Reform Demonstration Project for Sacramento County. RBS is designed as an 18 month intensive service program that focuses on permanency and provides a comprehensive approach to providing the right services, at the right time and in the right location, for youth who require group home care and their families. Six to nine months of services are provided while the youth is residing at CRH and then an additional nine months of services is provided in the community once the youth returns home or to the care of a non-related extended family member. Health Services - The CRH Health and Wellness Manager, a Licensed Vocational Nurse (LVN) provides oversight of our medical and nutritional programs. The LVN ensures that arrangements are made for children and youth to receive medical assessments with a pediatrician for the Child and Health and Disability Prevention Program and to address any possible medical concerns. CRH participates in the California Immunization Information Registry (CAIR) and Vaccines for Children program. Appointments are scheduled for follow up with primary care physicians, dentists, and optometrists to ensure that youth receive the best medical care while in our care. Activities & Recreation - Activities and recreation is a great way to keep our kids to stay occupied in a constructive and healthy manner. Daily activities are provided on campus for different age groups. As the children's length of stay is often unknown, we attempt to take them on as many off site outings as we can. We use gift certificates to take the children skating, to basketball and baseball games, and other fun places such as Scandia, and Golfland Sunsplash. Education - Valley Oaks School is a fully accredited public school located on site at the Children's Receiving Home and is a public school that is staffed and maintained by the San Juan Unified School District. The onsite school provides educational services to children and youth who for varied reasons cannot continue attending their home school. It is a unique classroom environment with the goal of providing educational continuity for these children and youth. Partial Hospitalization Program (PHP) - CRH operates a partial hospitalization program for adolescents with behavioral and emotional diagnosis. The program is a day program with a rich staffing model including individual therapy and group therapy. This program is funded through contracted rates with insurance companies for their insured client base.
