OneJustice brings life-changing legal help to those in need by transforming the civil legal aid system. OneJustice removes barriers to justice by serving as a source of innovative and replicable projects that expand the delivery of legal services

Healthy Nonprofits Program OneJustice's Healthy Nonprofits program provides training, coaching, and consulting to boards, executives, and senior management to build the leadership and management skills they need to survive and thrive in the increasingly complex nonprofit sector. During FY 2015/2016, OneJustice provided brief technical assistance and consulting on nonprofit management to 40 legal services nonprofits, and in-depth assistance to 6 organizations. (Continued Schedule O) OneJustice also conducted 5 trainings for nearly ninety legal aid nonprofit staff through the state. OneJustice completed the sixth year of the Executive Fellowship, an intensive 10-month program on nonprofit leadership and management, with 19 Fellows graduating in June 2016. OneJustice increased the staff attorney capacity at four legal services nonprofits around the state by serving as the centralized administrator for 11 post-graduate legal fellowships, allowing those nonprofits to hire new attorneys to serve more clients. OneJustice also continued to coordinate the annual Northern California Public Interest/Public Sector Careers Day, one of the largest public interest and government career fairs in the nation. The 2016 Careers Day was attended by more than 139 employees and more than 485 law students.

Pro Bono Justice Program OneJustice's Pro Bono Justice program expands volunteerism in the legal community, providing strategic planning, training, coaching, and resources to legal services nonprofits, firms, schools, and corporations on how to design and administer highly successful volunteer ("pro bono") legal projects. OneJustice also develops innovative pro bono delivery models, including focusing on the needs of rural Californians. During FY2015-2016, the Pro Bono Justice program brought together nonprofit and law firm pro bono leaders at the 2016 Statewide Pro Bono Conference in Los Angeles attended by 98 leaders in pro bono management from law firms, corporations, law schools, and legal services nonprofits. OneJustice also continued to staff and convene the Northern California and Southern California Pro Bono Managers groups. OneJustice's award-winning Justice Bus Project engaged over 560 volunteers to deliver 42 mobile legal clinics, serving low-income people in rural and isolated areas of the state. The Bay Area and Los Angeles Association of Pro Bono Counsel (APBCo) IMPACT Projects engaged over 280 pro bono volunteers to deliver 36 free legal clinics in isolated communities in the San Francisco Bay Area and south Los Angeles. These Justice Bus Project and IMPACT legal clinics primarily assisted low-income Californians with immigration, traffic record amnesty, criminal record clearance, and housing legal assistance. OneJustice also continued its work in the collaborative "California Pro Bono Training Institute" project to develop and distribute 19 training video modules on areas of law that were then accessed by 307 volunteers to prepare for pro bono opportunities. With over 30 years experience as the backbone for California's civil justice infrastructure, OneJustice's programs work within the existing service delivery system to close the greatest gaps in legal aid, while also testing new models and piloting new approaches to lead to sector-wide transformation. OneJustice works on a national level as a thought partner and resource, as well as representing the interests of California's legal aid sector in efforts to change policy and systems. OneJustice also supports the import and export of creative ideas by packaging its own approaches and projects for replication in other states and by identifying effective practices from outside California.

The process is as follows: OneJustice's Audit Committee reviews the Form 990 with the CEO. After approval by the Audit Committee for submission, the Form 990 is distributed via email to the entire Board of Directors for Board members to raise any questions or concerns. The Form is then submitted.
Form 990, Part VI, Section B, line 12c	OneJustice's conflict of interest policy requires Board members and key employees to disclose, on an annual basis, any interests that could rise to conflicts. Board members and key employees are given a disclosure form each year that asks them to disclose any conflicts, as defined by the policy. The policy also requires any Director who is affiliated with a prospective vendor, paid consultant, or grantee to abstain from voting with regard to any transaction with financial consequences to OneJustice involved that person or entity and, after disclosing his or her interest, to leave the room during discussion and while the vote is taken. At Board meetings, the Chair routinely reminds Board members about the policy and the conflicts requirement before any votes are taken involving transactions with financial consequences to OneJustice. The minutes reflect the Board's actions were in compliance with the policy when any such votes are taken.

The Executive Committee consists of the Chair, Vice Chair, Immediate Past Chair, Treasurer and Secretary of the Board, all of whom are independent persons. The CEO was not involved in the compensation review and approval process. During FY2015-2016, the Executive Committee reviewed executive compensation by using the board-approved OneJustice salary scale for the executive position. The CEO's salary scale and benefits were created based on comparability data from the 2015 Fair Pay for Northern California Nonprofits, the 2015 Center for Nonprofit Management Compensation and Benefits Survey, the 2013 National Center for Youth Law Salary Survey (a review of salaries at 36 social justice nonprofits in the San Francisco Bay Area), and the 2013-2014 Opportunity Knocks Age and Benefits Report. The Executive Committee decided that the CEO would not receive an increase in compensation during FY2015-2016 and that a decision about compensation increase would take place in fall 2016 following an evaluation of the CEO by the Board of Directors.
