Californians for Justice Education Fund, Inc s four regional offices in Fresno, Long Beach, Oakland, and San Jose organized 250 students to address educational inequities. In 2017, CFJ youth won several victories as part of our Relationship Centered Schools Campaign that is focused on supporting educators and students to build relationships that embrace and empower all students to pursue their dreams. Those victories included more funding for restorative practices, student and parent engagement, and counseling and wellness supports. CFJ youth also engaged in the Local Control Funding Formula budget process in four school districts where they advocated for equity, transparency, and accountability in their districts budget decisions. Leadership Development 250 youth leaders participated in CFJs year-round leadership development program, which focuses on political education, skills building, and personal growth. The program features three intensive training institutes in addition to weekly and monthly programming Campaigns CFJ engaged 6,256 people over the last year in awareness and advocacy efforts related to our Relationship Centered Schools campaign. In 2017, CFJ launched the Defend and Mend Coalition in partnership with 18 organizations in response to a wave of attacks against the Local Control Funding Formula. Our wins this year represent a second phase in improving the Local Control Funding Formula - to increase the role of student voice in decision making and allocation of state resources - and advancing Relationship Centered Schools - to address and improve social emotional learning. In the last year weve moved 3 school districts and 7 schools to commit to implementing a Relationship Centered Schools (RCS) framework. Weve built strong relationships within each district and have maintained a continued presence as an advisor and advocate at the state level, which has allowed us to more easily partner with decision-makers to push through new policy changes. In addition to local wins, we were able to win \$28.3 million for school climate and community engagement in the state budget.
