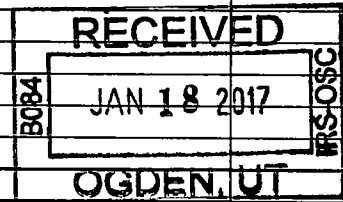

STATEMENT OF EXPLANATION FOR AMENDED RETURN

The Form 990-PF return is being amended to adjust for unrelated business income that was inadvertently included on the original 990-PF return relative to the sales of publically traded partnership (PTP) interests. Ordinary gains from sales of the PTP interests have been removed from Form 990-PF and are now reported as Unrelated Business Income on Form 990-T Form 4797.
